

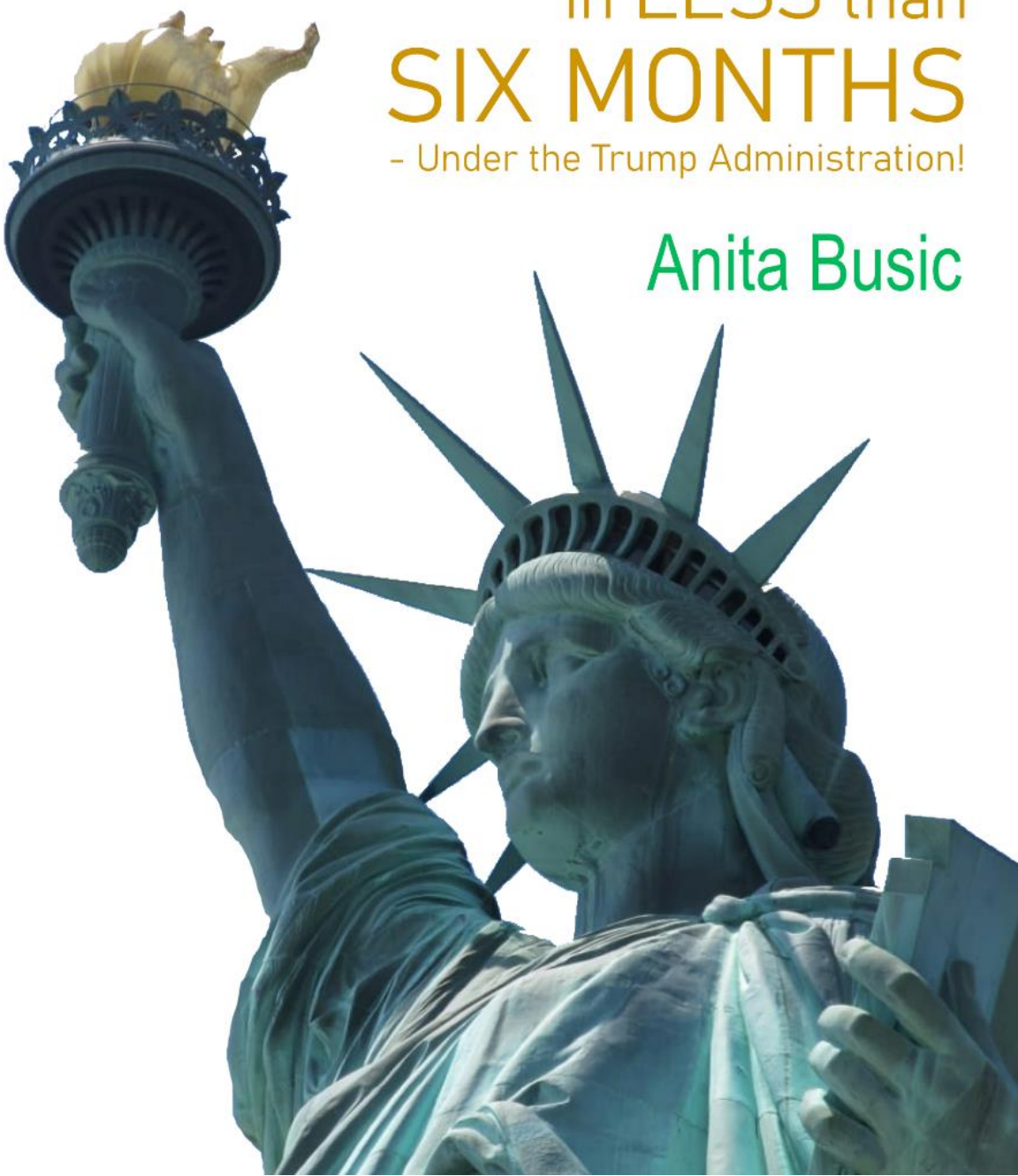

FOREWORD

I was not originally planning to immigrate to USA. All the events outlined in this book, happened to me without my conscious effort. You could definitely expedite things for yourself, if you put in conscious effort.

Fair Notice

Less than six months relates to the time from filing the Adjustment of Status, from O-1A, to EB-1A. O-1A is the non-immigrant visa for people of “Extraordinary Abilities” i.e. “Exceptional Qualities”, while EB-1 is the immigrant visa i.e. Green Card, also for people of “Extraordinary Abilities”. The A in O-1A and EB-1A, refers to people in business, i.e. entrepreneurs, including startup founders, especially those ones with an award-winning innovation, as in my case. If you belong to this category, this book is for you!

1. This book is not intended to replace advise of immigrant lawyers! It is only for entertainment purposes. Please do consult with immigrant lawyers specialized, or highly-experienced, in obtaining O-1A i.e. EB-1A visas. Requirements are the same for both, but on a higher level for EB-1A.

If you qualify well, fulfil at least three out of 10 requirements (preferably four to five) for three to four times (preferably four to six) and can prove it to USCIS’s satisfaction, insist on applying for EB-1A, not O-1A. Most immigrant lawyers prefer to go down the route of obtaining first the O-1A, rather than the EB-1A, as they are more certain of a successful outcome, plus they can charge you additionally for the EB-1A.

TIP 0-1

I strongly advise hiring an immigration lawyer instead of going the do-it-yourself way. It will cost you between \$10,000 - \$15,000, but is well worth the investment. Your chances of success will be greatly amplified.

2. This book is educational in the sense that it can teach you how to fulfil the necessary requirements to apply for O-1A/EB-1A visas. I am sharing my personal experience with you how I managed to fulfil the requirements, and how you might copy my steps to do the same.

Some of my achievements are specific to my profession, but the tips and advice are translatable to other professions as well. I sincerely believe that the tips will be useful to you, if you are looking into immigrating to USA as an extraordinary entrepreneur.

3. This book does not cover the preparation for the USCIS interview process, medical check-up, nor does it give advice and tips on how to properly enter and leave USA with various visa types, as well as potential issues you might face with your fingertips – if your hands have unusually soft or hard skin.

Immigration to the United States might be challenging, but it can also be very rewarding. Don't get discouraged if your visa application is rejected. You can learn from your mistakes and apply again. I wish you the best of luck in growing your business and, if you find that relocating to USA is essential to this growth, the O-1A/EB-1A might be the right visa option for you.

NOTE 0-1

At the time of writing this book, March 2020, there are **no national limits** and **no backlogs** for either of these two visa types, as US government always welcomes people who can prove themselves to be of extraordinary abilities.
